Dear Neighbor,

Orange has continued to move forward over the last two years, overcoming challenges that the policies from the state and inflation have placed in our path. My Republican team has led the way to strong economic development, excellent schools, continued protection of our green open spaces, and financial management that has helped to ease your tax burden. Controlling Taxes: State-mandated property revaluation is done on a periodic basis. In the last revaluation, residential property values in Orange went up an average of 38%, while commercial property values increased 16%. We have worked hard to mitigate the impact of these changes by phasing in this increase over a three-year period. More importantly, despite price pressure caused by inflation, we have controlled spending.
